PAOs are highly branched isoparaffinic chemicals produced by oligomerisation of 1-octene, 1-decene, and/or 1-dodecene. The crude polyalphaolefin mixture is then distilled into appropriate product fractions to meet specific viscosity specifications and bydrogenated.

Read across data exist for health effects endpoints from the following similar *hydrogenated* long chain branched alkanes derived from a C8, C10, and/or C12 alpha olefins:
